# Meet Dr. Nene Okunna

#### What made you choose West Chester University for a career?

I had got to the point in my career where I thought a change was necessary. Also, I encourage my students to embrace high standards in their work and strive for excellence. I encourage them to think outside the box, and to translate the content they learn in my classes to their own health as well as the health needs of the local and global public health community.



# Meet Dr. Omosehin Moyebi



Ph.D., MPH



Dr. Omosehin Moyebi is a teaching faculty fellow with the Department of Health and the first Frederick Douglass Scholar in the College of Health Sciences, West Chester University of Pennsylvania (WCUPA). Dr. Moyebi is an alum of WCUPA where he obtained his Master of Public Health in Environmental Health in December 2017. After his graduate degree at WCUPA, Dr. Moyebi proceeded to the University at Albany School of Public Health, Albany, New York and completed his Ph.D. in Environmental Health Sciences in 2022. His doctoral research was on the effect of air pollution in relation to daily hospital admissions and emergency room visits due to cardiovascular diseases in Karachi, Pakistan. Dr. Moyebi's career goals are to work in the academia imparting knowledge, and as an environmental health professional protecting the health of both the public and the environment.

Dr. Moyebi's research interests focus on the concentration levels of size-segregated particulate matter (submicron, fine, coarse, and total suspended particles) and particulate matter constituents (black carbon, metals, ionic species, and gaseous pollutants) in urban centers of developed and developing countries. He has conducted air quality investigations in both developed and developing countries with some of the studies already published in peer-reviewed international journals. Dr. Moyebi delivered the Fall 2022 Frederick Douglass Scholar Public Lecture entitled "Fine Particulate Matter and its Chemical Constituents' Levels: A Troubling Environmental and Human Health Situation in Karachi, Pakistan".

Dr. Moyebi's advice to current MPH students and those that are already pursuing their doctoral degree is to persevere. It is achievable and you can do it. Nevertheless, the first step is to get your priorities right, define your research interest, and choose a mentor that would create time to help you become the professional you envisioned. Familiarize yourself with faculty research in your area of study before choosing a mentor to work with. Faculty members with funding/grant are usually your best bet. Please choose a research area that you are passionate about because you are going to spend most of your time working on your dissertation research. Do not be in competition with others, but be focused, organized, collaborate/network with colleagues, and look for opportunities to attend scientific/research conferences for your career advancement. Good luck.

I am glad to be back at WCUPA as a teaching faculty and thankful for the opportunity.

#### Any advice for current environmental health track students?

Do not hesitate to contact your professors. They are there for you for support, learning and just to meet and casually converse during their office hours. Also, learn to start networking in different organizations because this can be a key to your success not just professionally but also personally.







## Stacy Wright, MPH

#### How was your experience in the MPH at WCU?

I had a great experience with the department and at WCU. I liked that the class sizes were (fairly) small, so I had the opportunity to get to know my professors and peers very well. I found the courses challenging but eventually realized that they really strengthened and developed my research and writing skills and, motivated me to step outside of my comfort zone. Lastly, the program has cemented my passion for community health and paved the way for where I am today.



#### How has your MPH in Community Health helped you along the way?

My career path has never been linear, but the MPH program has helped in multiple ways. After receiving my degree, I was part of multiple research projects that strengthened my research skills and helped solidify my research area of interest. When I moved to my home country of Jamaica, I knew right away that I wanted to work with the Ministry of Health and Wellness, the country's primary public health delivery system on the island. It took some time to get my foot in the door, but I found my niche in the Health Education and Promotion unit. Within my role, I immediately utilized competencies from the program to aid in creating and implementing tailored strategies in the community. After 6 years of having my degree, I am now pursuing my doctorate at the University of Florida in Health Outcomes and Implementation Science. Having the MPH degree has really set me apart and provided me with the necessary techniques to promote culturally diverse and appropriate health education methodologies.

#### What were some advantages and challenges as an international student?

#### **Advantages:**

- Providing a global perspective on issues
- Sharing my culture, food, and language with others
- Making friends with people from around the world

#### What was your favorite place to hang out?

I loved going to the Painted Plate, a paint-yourown pottery store. It was a great way to destress. I also loved dining out at local restaurants with friends, my favorite would be Limoncello. Every time I am back in West Chester, I visit this restaurant; the food is so delicious, and it has such a warm and friendly environment.

#### **Challenges:**

- Not having your family and close friends nearby
- Traveling back home can be costly
- Not being able to take advantage of certain scholarships, job opportunities, and grants because of visa restrictions

#### Any advice for current students?

Take advantage of all the opportunities that come with being in this program. If at any point you feel you are not qualified for something, pursue it anyway. One of my favorite quotes summarizes it best, "if you don't go after what you want, you'll never have it. If you don't ask the answer is always no." Finally, while in school, be patient with yourself you are learning something new, so do not be afraid to ask questions and seek help.

How was your experience in the MPH at WCU?

My experience in the WCU MPH program was everything I needed. The professors in the MPH program were committed to students' success and they were accommodating given the uncertainty of the pandemic. One of my biggest takeaways from the program was to continue developing my professional skills, not only in the traditional sense with workshops and courses, but also through networking, connections with others, and collaboration.

My path into the MPH health care management track was a bit untraditional but did impact the road I have been on upon completion of my MPH program. Getting into my fellowship program is one of what I hope to be many accomplishments that will come from completing my MPH program. If I did not take the advice of the professors and utilized the campus resources for interview improvement, I may not have had my fellowship. There have been little suggestions along the way that have helped me to become better.

How has your MPH in Health Care Management been helpful along the way?

How is your administrative fellowship going to help you in your future professional pursuits?

The administrative fellowship has been an extension of my education. I have had the opportunity to sit next to the President of the hospital in high-level meetings with the multi-system President and other C-suite executives. I present my projects to people at all levels of the organization from patient-facing to the President. Although I have only been in my program for 3 months, I have been a part of amazing opportunities. This fellowship will undoubtedly help me in decision-making at whatever organization I work at in the future. Looking at community education programs, workforce issues and revenue cycle inconsistencies are only a couple of the areas I get to explore and improve my knowledge base on as I move through this fellowship. This is the knowledge that will benefit me in future roles in and outside of the healthcare setting.

I would advise healthcare management track students to explore what opportunities are available. Don't be afraid to ask questions or ask for advice. Don't limit yourself and have a plan for achieving your goals.

Any advice for current health care management track students?





#### How was your process in applying for ALE?

The process for applying for an ALE was straightforward and well laid out. The MPH program offered clear guidelines on what would be an acceptable placement site and what projects would count as major projects. When thinking about potential sites, I focused on the following: (1) location - finding a placement site near where I would be living (Bucks County, PA), (2) the organizational mission and programs implemented, (3) the potential initiatives I could work on. I directly emailed or called various sites that I was interested in working at and set up interviews with several of them. I not only wanted my skill set and interests to be a good fit for the organization, but I wanted the organization to be a good fit for me. I ended up selecting St. Mary Medical Center as an ALE site as it was close to where I lived and offered a variety of learning opportunities.

#### What are your tips and tricks for finding a site supervisor of interest?

Interview in-person if possible! You will learn so much about someone during an in-person conversation based on body language, facial expression, demeanor, and work style. Ask the supervisor what type of leadership style they have and ensure this meets your needs. Inquire about past students they might have had and how those experiences have helped them grow and learn. Also, ask if any prior interns are now employed with the agency. You can always ask for a short meeting with them to learn more about the supervisor.

#### Any other advice for MPH students graduating?

Invest your time in finding a mentor. Whether that is a professor you connected with, MPH alumni that have established careers, or someone with knowledge and life experience you value. Having a mentor not only can open doors for you, but they can teach you new things about yourself and shed light and wisdom as you establish a career. A mentor doesn't have to be a formal relationship where you meet regularly, but it can be someone to lean on, openly ask questions to, and seek advice and guidance from. I encourage you to think about whom you will turn to when you have career-related questions, challenges, exciting news to share, or need advice. Having that support system is important as you enter the workforce!

#### How was your overall experience of the MPH program?

I absolutely LOVED the MPH program at WCU. When people ask me about the experience, I can say with confidence that I left the program with skills and not just knowledge. I feel the MPH program sets students up for success as a public health practitioners by not only educating students but giving them the tools to succeed in the workforce. I left the program knowing I could plan, implement, and evaluate public health programs and this was an attractive skill set when I applied for jobs following graduation.

You should research each GA position and see how they align with your program.

What's your role?

## Dr. Harry Holt Recognized in Spotlight PA







Dr. Harry Holt, Dr. Ramona Stone, and Dr. Christina VandePol's (former Chester County Coroner) research was recently highlighted in an article that was published by Spotlight PA. This article has also been highlighted in newspapers and news sources throughout the state of Pennsylvania. The research was funded through a competitive grant awarded by the Center for Rural Pennsylvania. The researchers interviewed and gathered survey data from coroners, medical examiners, and forensic pathologists throughout the state. They collaborated with Penn State Harrisburg. Center for Survey Research and the Pennsylvania Coroner Association. All research work was completed with the assistance of WCU MPH students.

#### The Spotlight on PA article highlighted the findings of the study which include:

- There is a lack of uniformity and standardization of training, education, policies, and resources among coroner and medical examiner (C/ME) offices in Pennsylvania, with the resultant inequitable application of death investigations across counties.
- · Only a small minority of county C/ME offices are accredited by the International Association of Coroners and **Medical Examiners** (IACME). The multiple and complex county processes and standards make standardization of death investigation and performance impossible.
- Most rural and urban coroners reported neutral or inadequate support from their county officials who control almost all their funding.
- Pennsylvania, like the rest of the United
   States, has a severe shortage of forensic pathologists who can serve as medical examiners or perform autopsies.
- Most C/ME offices are operating below benchmark levels of funding.
- Insufficient financial resources, lack of time for education and training, and the part-time nature of their position pose barriers to certification or data collection and communication for many rural death investigators.
- The opioid crisis and the COVID-19 pandemic have had a significant impact on C/ME office operations and caseload.

The principal investigators for the study are grateful to the Department of Health for its contribution of \$29,273 which funded, among other items, MPH student stipends, and tuition. MPH students who contributed to the study and who were supported by the grant include Dr. Amrit Baral (Class of 2021), Danisha Heyward (Class of 2022), Balee Lesser (MPH Candidate), Alyson Marsden (Class of 2021), and Miskyat Oladosu (Class of 2021).

Dr. Speidel is a retired physician with specialization in Emergency Medicine. The appearance was an opportunity to share insights and a healthcare management perspective on recent hospital closures and health system acquisitions in the Delaware Valley and Pennsylvania. - Are there economies of scale in healthcare delivery?





# Using Faculty Learning Communities in Promoting DEI Teaching Practices

Institutions of higher education have a responsibility to provide students with the knowledge, skills, and abilities to employ the concepts of diversity, equity, and inclusion. However, most faculty lack experience in conveying this information to students. College-level faculty learning communities (FLC) provides the opportunity to learn discipline-specific approaches around areas such as implicit bias, promoting dialogue around diversity, equity, and inclusivity, and facilitating difficult conversations in the classroom. The goals of this session were to engage participants to apply these approaches, provide a framework to be utilized, and discuss lessons learned from the research and one institution's approach.

The Quality Matters initiative is a university-wide effort funded by the Office of Digital Learning and Innovation (ODLI) that aims to promote online course quality and teaching effectiveness. The goal of the initiative is for WCU online courses to be certified by Quality Matters Higher Education Standards.







# Dr. Sharon DeJoy Receives State Funding for COVID Vaccine Outreach to Midwives



The Pennsylvania Development of Community and Economic Development (DCED) is funding the work of Dr. Sharon DeJoy, a faculty member in the College of Health Sciences Department of Health, aimed at increasing the rate of vaccine uptake among women seeking perinatal care from midwives offering out-of-hospital birth services.

The social marketing campaign was co-developed by a class of senior public health students and a public health intern under the direction of Dr. DeJoy. The project is using social media and client handout materials to increase COVID vaccination rates among vaccine-hesitant families.

After completing her doctorate in Public Health from the University of South Florida, Dr. DeJoy joined the faculty as Assistant Professor in 2012. Prior to accepting her current position, she was an Assistant Professor of Community Health at the State University of New York at Potsdam. She teaches both undergraduate and graduate public health courses and directs the BS in Public Health program. Dr. DeJoy has conducted community-based research and consultation in maternal child health for underserved populations. She has authored and co-authored various peer-reviewed articles and presented them at international conferences. Dr. DeJoy was formerly a Licensed Midwife in Florida.







## Career Corner with Lt. Gifty O. Tuffour, MPH, BSN, RN

The MPH program was proud to welcome MPH Alum Lt. Gifty Tuffour, Cdr. Brandon Johnson, and Lt. Diego Ratzlaff on October 28 to talk to students, faculty, and partners on the United States Public Health Service Commissioned Corps.

How did the WCU MPH program prepare you for your current position as a Lieutenant in the United States Public Health Service? What other training did you find beneficial to your role?

West Chester University MPH program is a robust program that has prepared me to gain broad knowledge and skills in the core areas of public health. For instance, I can implement, monitor, and combat contemporary healthcare issues. The MPH program has tremendously prepared me to work on the front lines of public health. As a Lieutenant in the United States Public Health Service, I am privileged to serve along with providing leadership, oversight, staff training, and education on compliance with standards and accreditation, incident reporting, risk management, quality improvement, environmental health, safety and security, occupational health, infection prevention, and all-hazards emergency preparedness. Another training or continuing education benefit to your role is attending public health training to increase leadership and management skills.

From your interprofessional nursing-public health lens, what are the critical training needs for public health professionals to best promote health and wellness to the diverse populations your agency serves?

Training in public health, health promotion, and cultural competency are integral aspects to best promote health and wellness to diverse populations. Maintaining the highest level of competence in health education is a PLUS such as obtaining the Certified Health Education Specialist (CHES) and Master Certified Health Education Specialist (MCHES). Also, I recommend Emergency Preparedness training, obtaining leadership skills, and having a passion for serving underserved populations.

How can public health professionals be better poised to promote health equity in the region?

To achieve health equity, public health professionals must change the systems and policies that have resulted in the generational inequalities that heighten racial and ethnic health disparities. Public health professionals should continue to advocate to advance public health and health equity through targeted social determinants, particularly on behalf of poor and disadvantaged population.
