



### SOPHE 2022 Student Health Edu-thon Winners

Brynn Myers, Avery Krot, and Ava Sweeney (BSPH students) recently took third place in the 2022 Society for Public Health Education (SOPHE) Student Health Edu-thon. This case competition-style event takes place every year at the Society for Public Health Education (SOPHE) national conference. The team was given a prompt with background information about youth mental health and tasked with developing a digital intervention to address the problem. They went through the program planning process with the National Commission for Health Education Credentialing (NCHEC) competencies of a health education specialist as a guide. They demonstrated many of the skills they have learned in the BSPH program thus far, and ultimately the team designed a podcast intervention for 12-17 year-olds in Philadelphia County focusing on various mental health topics. The podcast was titled "Young and Loud!". The team gave a 30 minute presentation of the program over Zoom, followed by a 15 minute Q&A with the judges. Dr. Rebecca Rich served as their faculty mentor throughout the process.


#### Secretary: Sunita Wolford

# 2022 AEHAP STUDENT RESEARCH COMPETITION WINNER

### **COLLIN ORIENTE**



AEHAP sponsors the Student Research Competition to highlight important environmental health research being conducted by students enrolled in National Environmental Health Science and Protection Accreditation Council (EHAC) accredited environmental health degree programs.

His research project in seminar (ENV 455) focused on "Analysis of the Relationships Between Drinking Water Violation Rates, Income, Race, and Population Size in Pennsylvania Counties". He meticulously worked on a huge database -drinking water reporting system and ran multiple combinations of statistical tests to identify risk factors for violation rates in PA.

He will be presenting his project at two events. The first event is virtual and is on May 10, 2022 at the AEHAP Student Symposium and the second is at the National Environmental Health Association (NEHA) Annual Education Conference (AEC). This year the AEC is in Spokane, Washington June 28 through July 1, 2022. The award includes \$1,000 and up to \$1,000 in travel expenses to present his research.

While in the MPH program, Ghecora obtained a graduate certificate in Emergency Preparedness in Public Health that gave the skills learned in addition to the MPH track courses which better prepared her to address ecological emergencies in the clinic and ambulatory setting. Ghecora's interprofessional training has best prepared her to meet the needs of patients having had a wide variety of educational and work experiences. This enabled her to provide compassionate care and understanding for her patient's experiences and perspectives in supporting their needs. When asked, how do you bring together your education, training, and expertise in nursing and public health in your current work? Ghecora's response was, " Combining my deep understanding for science, public health, nursing and patient experience gives me a unique understanding of how to be an advocate and educator for my patients. Caring for patients and their families as a whole and addressing their needs uniquely not only improves the patient experience but also improves health outcomes. This also influences patients to have an active role in their care. One example is helping patients get connected to integrative health resources".

The Master of Public Health program aims to prepare public health professionals that advocate and promote health, wellbeing, and human rights for all people. After being conferred the MPH 8 years ago, my public health practice is executing on meeting the needs of the community I serve. This remains true in my previous work with the AIDS Activities Coordinating Office a division of the Philadelphia Department of Public Health and my current work as a Cardiothoracic Surgical Step-Down Nurse within Main Line Health.

The MPH program allowed me to gain the necessary knowledge and skills needed to fully understand the complexities of health at the individual and community level. The program placed a great emphasis on addressing the social determinants of health, stress reduction, health education and interprofessional practice within public health. While patients are in my care and throughout the development of discharge planning with the clinical care team, the aforementioned skills and knowledge are utilized to meet the needs of said patients.

From your interprofessional lens, what are the critical training needs for public health professionals to best promote accessible, equitable, and quality care to diverse populations in our region?

> As communities become more diverse, the critical training needs must focus on access to services, workforce utilization, interagency collaboration and community involvement in any development and evaluation of public health programming. A true assessment of what the community needs are must be the starting point to have a more equitable approach to public health. Public health professionals should be committed to involvement in local, state, and federal governmental affairs to be certain community health needs are identified and addressed by elected and nonelected officials.

How can public health professionals be better poised to promote health equity in the region?

I am a strong proponent of interagency collaboration and proper utilization of resources within a region to attain optimal health equity. As we know, the community needs most times is multifactorial, yet many public health organizations tend to have limited funding and an approach that makes it impossible to address all needs. In order to address the social determinants of health all stakeholders within our community must partner to improve health, well-being and quality of life within the region.

# DR. ZEINAB BABA

#### Co-facilitator of the College of Health Sciences' Diversity & Inclusion Faculty Learning Community

Dr. Zeinab (Zee) Baba, has been co-facilitating the College of Health Sciences Diversity and **Inclusion Faculty Learning Community** (DIFLC) with Dr. Kimberly Johnson (Associate Professor in Nutrition) for two years now. The DIFLC came about because there was a feeling that faculty could use a space to learn about and share their efforts on inclusive teaching in the classroom. There has been a realization that the general student body is more diverse than the faculty, and as faculty we needed a forum where we could be intentional and focus on inclusive teaching while providing evidence-based resources on inclusive teaching. As a co-facilitator some of the responsibilities include facilitating sessions (three per semester), outlining topics for each session, selecting appropriate readings and compiling resources for faculty, recruiting guest speakers, and being an active learner in the DIFLC. The DIFLC is designed to be a space where faculty can share their experiences with DEI in the classroom and we can support each other in addressing DEI in our teaching practices and philosophies.

The focus of the DIFLC is identifying areas in our teaching where we can be more inclusive. There are wide areas to consider when it comes to inclusive teaching. It may involve diversifying the readings that are assigned so that they illustrate different points of view, changing attendance policies to accommodate students of different circumstances, or integrating different teaching methods. One of the best outcomes from the DIFLC has been sharing struggles in the classroom and getting feedback from all the faculty involved. We have a diverse group of faculty from all departments in CHS, and though we all teach different subjects, the goal of incorporating DEI into teaching and understanding the diversity of our students is at the forefront for the members of the DIFLC.



#### How may students become involved or learn more about incorporating DEI in their workplace?

- 1. Find out if there is a Chief Diversity Officer or someone with similar responsibilities in your workplace. We are seeing more and more employers value the role that DEI plays in having a successful workforce and the need to designate an individual to maintain those efforts.
- 2. If your workplace does not have a DEI officer, you may decide to start a group similar to the DIFLC where you come together with a small number of individuals and assess how DEI factors into your workplace. DEI can impact various areas of a job. It could be the clients or vendors you are supporting, the employees, the spaces and communities that are occupied by the workplace, or projects being designed. Various areas can be improved by insisting on a DEI framework.
- 3. Make it a point to ask about DEI philosophies when you interview for a job and be prepared to share what DEI would mean to you as an employee. While a workplace may have a DEI statement – having a statement and actions related to that statement are two different things. If you are in a job now, think about what is most important to you and ask those questions of your workplace.

#### Advice for Students

"Be vocal. As faculty we are experts in the subjects we teach, but we are not experts about what you need. One component of the DIFLC that has been impactful is a panel we do with students of color about their experiences in the classroom. We cover so many topics: the syllabus, attendance policies, course readings, representation in the classroom, assignments, technology access, students with different abilities, etc. It has been particularly insightful for me because some of these are areas I would not have thought of as being a barrier to inclusivity. Faculty may do their best to try and envision different situations and how to address them but we need help from the students to make sure that what we are doing is helpful. Sometimes it can be intimidating to ask for what you need but know that there are support networks on campus to help you advocate for yourself. The same can be said for students in the workplace or about to go to the workplace: ask for what you need and what you think others may need. As we strive to make our college more inclusive please be patient with us. There are so many moving parts that are trying to come together and we will make mistakes. Know that we are learning from everything we do to ensure that everyone is seen and heard".

### Student Research and Creative Activity Award Recipient

#### SARA HASSAN

Sara will be presenting her abstract "The Importance of Early Childhood Development Programs for the Growth of Refugee Children" at Research and Creative Activity Day on April 29. She was mentored by Dr. Zeinab (Zee) Baba. Read her abstract below.

#### "The Importance of Early Childhood Development Programs for the Growth of Refugee Children"

This study was conducted to illustrate the benefits of early childhood development (ECD) programs for refugee children and how the implementation of these programs can support their socio-emotional growth. This study is critical because although research evidence has been presented to visualize the value in affective interventions and ECD programming, the humanitarian system has failed to include them as a core component in their response strategy. There is a need to examine implementation quality and the why and how specific aspects of interventions work. By delving into more context-specific research, ECD programs will have a higher implementation rate and provide more benefits to children. A systematic literature review was performed to identify conceptual frameworks of early childhood development programs for refugee children. A content analysis was carried out to identify the structure of ECD programs, what the outcomes are for refugee children, and how effective models can be replicated in the United States. The search results were narrowed down to select articles published between 2018-2022 focusing on programs targeting refugee children ages 2-18 in refugee-hosting countries. The results demonstrated the benefits of ECD programs and why they are crucial for the growth and development of refugee children. These programs must become widely available in all refugee-hosting countries to provide support to the positive wellbeing and development of refugee children.

### PENNSYLVANIA MEDICAL EXAMINER AND CORONER OFFICES STUDY

Dr. Harry Holt, Dr. Christina VandePol, MD, Dr. Ramona Stone and Balee Lesser (MPH candidate) recently completed a study of Pennsylvania medical examiner and coroner offices. The goal of the study was to determine the impact of the COVID-19 pandemic and the opioid crisis on the office operations and caseload of coroners and medical examiners. The unique experiences of rural coroners and their offices was highlighted in the study's findings.

The study was funded by the Center for Rural Pennsylvania with an overall budget of \$79,184. The principal investigators for the study are grateful to the Department of Health for its contribution of \$29,273 which funded, among other items, MPH student stipends and tuition. MPH students who contributed to the study and who were supported by the grant include Dr. Amrit Baral (Class of 2021), Danisha Heyward, Balee Lesser, Alyson Marsden (Class of 2021), and Miskyat Oladosu (Class of 2021).

The study and its results will be presented as an oral presentation in June at a conference hosted by the Pennsylvania Public Health Association (PPHA), the Pennsylvania Office of Rural Health (PORH), the Penn State College of Medicine's Public Health Program, and the Society for Public Health Education – Pennsylvania Chapter (SOPHE), in collaboration with the Pennsylvania Nutrition Education Network PA NEN).



### HEALTHCARE LEADERSHIP NETWORK OF THE DELAWARE VALLEY

MPH students enjoyed hearing the leadership journeys of several members of the Healthcare Leadership Network of the Delaware Valley. The speakers provided an overview of their journey to their current position and shared the lessons learned along the way. The spoke of the value of mentorship and then giving back by serving as mentor. The shared how networking and focusing on relationships and community service played an important role in their professional life. They discussed critical management skills that students needed acquire in finance, technology, strategy, and leadership while in the MPH program. Ultimately, the speakers emphasized the value of nurturing personal relationships with colleagues to serve patients and their families.
