AGENDA ITEM I – CALL TO ORDER:

Chairperson Tomlinson called the meeting to order. Chairperson Tomlinson led the Pledge of Allegiance.

AGENDA ITEM VI – REPORT OF THE PRESIDENT

Chairperson Tomlinson continues and calls on President Fiorentino for his report.

President Fiorentino proceeds with his report. "Yes. Thank you, Senator. Good afternoon everyone. Obviously, great time year, Jeff mentioned commencement. We had a very successful commencement; 16 ceremonies over 3 days. As you know, we run small ceremonies, very intimate, and breakdown by college, which has been very well received by our students and their families. And I have to say that if you happen to see any of the ceremonies, they all run very smoothly, but under the surface there is a team of people working furiously to figure out how to put on 16 commencements over 3 days. And Andy Lehman, who is present, but that effort I also have to give kudos to Mary Beth Kurimay and actually many, many people from the campus, like too many to name, but the volunteers and staff working overtime to make sure that everything just went very smoothly in the ceremonies and that was wonderful. And I can tell you, having the opportunity to look into the eyes of the graduates as I shook their hands, and I think Dr. Osgood could certainly say the same thing. Anybody who thinks that getting a college degree is not important these days, is not really tuned into what's going on. They were excited to be graduating, thrilled, happy, and we're all very excited about where they're going to go from

here. So, definitely the time of year to get our batteries charged, we're all exhausted from the weekend, but it's very satisfying with what is happening in this institution. So, thank you all for participating.

I'll also mention that this was the first graduating class for the biomedicalengineering program, and the first graduating class for the physician's assistant program, both major milestones for us as an institution.

A couple of other interesting things to report. I'm pleased to report that the university was selected by the United States Department of Education as a green ribbon school for post-secondary sustainability. This prestigious award was a culmination of the hard work of our Office of Sustainability in conjunction with the support from the West Chester University Sustainability Council. I would like to recognize our Director of Sustainability, Dr. Bradley Flamm and Dr. Aliza Richman, who is the chair of the WCU Sustainability Council. We are nationally recognized as a school committed to sustainability, and that is a significant accomplishment. And we will be attending an award ceremony in Washington, D.C. in August and I understand that Andy Lehman and Brad Flamm will be attending to represent the University.

I wanted to extend kudos to Human Resources. Yesterday, and part of today, was our employee appreciation event. We had a great day yesterday. People gathered over in the SECC. We had a big luncheon and lots of activities, and a keynote speaker. It was very well attended, I think, very much appreciated by the staff and the HR folks did a really great job setting that up. And then today, there was a lunch over in the Rec Center, and lots of activities. Unfortunately, I had to put my suit on for the COT or I would've been there for the floor hockey game. But I do also want to mention, I happened to have a conversation while I was over there with Mike Reno, who is the Director of the Rec Center, and we started talking about right intermural activities, and I had no idea, and I asked him to send me some statistics, so I just want to read through this quickly. This is just intermural sports activities on the campus. I said, well you know, how many teams participate? And he said that there were 49 flag football teams; 28 indoor soccer teams; 73 5-on-5 basketball teams; 28 outdoor soccer teams; 34 softball teams, with a total of 3,036 participants in all these various things; and then group fitness activities, there were 979 sessions with a total of 10,479 total participants. So, you know, when we talk about student health and wellness, this is very impressive that we have this level of activity in our intermural sports, and I had no idea. So, I thought that was something worth just bringing up here today, and to just note that we have such a thriving intermural sports program here at the University.

Just a couple of quick updates. We've had the Gala since our last meeting which we had mentioned to you. We raised \$120,000 for scholarships, and it was attended by 250 people at Longwood Gardens, which was fabulous. Also, the final outcome of our charter day of giving, we raised \$175,929 on our charter day of giving, which is just wonderful.

We also had an event attended by Senator Casey and Representative Houlihan to commemorate, and honor the fact that they were able to secure for us a \$700,000 Federal grant to support STEM education. And the Senator and Representative were on campus, we had a nice ceremony and they took a tour of the building. It was a very nice day.

We had a terrific alumni weekend. The weather was not cooperative, but people showed up anyway and celebrated in the tent. We had a very wet spring football game, a lot of enthusiasm, and Coach is very excited about the recruiting class coming in. So, we're expecting good things there.

And with that I want to introduce Chief Ray Stevenson, who, by the way, Chief got his own master's degree this weekend, right?

The Chief is going to make a special presentation for us here as part of my remarks.

Chief Stevenson steps forward with Captain Rob Herzog and proceeds, "Hello, everyone! With me is Captain Rob Herzog. I wanted to acknowledge, on November 23rd, while Captain Herzog was going to his canine service training, he came upon a vehicle stopped at a stop sign, not moving. So, Captain being the Captain, exited his vehicle and as he approached the vehicle, the vehicle start drifting forward and went down the embankment and came to a dead end. And the Captain responded and found the gentleman slumped over on the passenger side. So, Captain Herzog jumped into action, was able to get the gentleman, Mr. Chalfont, out of the vehicle and administer, AED and CPR. And for his heroic actions, Mr. Chalfont made it full recovery. He has been at our station several times to thank him with all kinds of food, gifts, and to stop and say hi. So, I just wanted to acknowledge Captain Herzog's actions, especially with what goes on now in law enforcement, you know there's a negative perception and I think it's high time that we celebrate the good things in law enforcement. So, thank you very much.

And if he seems a little uncomfortable, Rob is not the one to be at the forefront.

President Fiorentino remarks, "So we're not going to get a speech? Rob, we're very proud that you lept into action, and I would expect nothing else. And it's amazing that our police officers are just prepared to encounter things like that and leap into action. So congratulations, and I'm sure from your perspective, it was just what you would expect to do in a situation like that. But for the rest of us, it's quite impressive. So, thank you!

Okay, and the purchase orders and contracts. March 1st, 2023, through April 30th, 2023 are listed in materials for your review. If there are there are any questions or concerns my cabinet and I are available to discuss them with you. And if there are no question, Mr. Chair, that concludes my report.

The Student Government Association Transition Ceremony was held in Phillips Conference Room on Thursday, April 27th to swear in the new SGA Executive Board. were held on Tuesday, May 2nd in the SECC and a total of 22 senate seats, that represent different areas of campus, were filled. In an effort to engage more students, elections were also held via D2L instead of Zoom for the first time since the pre-pandemic.
