SPECIAL MEETING OF THE COUNCIL OF TRUSTEES PHILIPS BOARD ROOM - PHILIPS MEMORIAL BUILDING WEST CHESTER UNIVERSITY OF PENNSYVANIA DECEMBER 16, 2016 12:00 P.M.

The special meeting of the Council of Trustees of West Chester University of Pennsylvania was held on December 16, 2016, in the Philips Memorial Building, 3rd floor Board Room.

AGENDA ITEM I - CALL TO ORDER:

Vice Chair Matlawski (on behalf of Chair Fillippo) called the meeting to order with the pledge of allegiance to the flag at 12:04 p.m. Members present were: Dozor, Silberman, and Long. Members by conference call were: Franklin, Ireland, Lewis, Fillippo, Moskowitz, Matlawski, and Tomlinson.

Absent, but accounted for, was Member Kinsey.

The Vice Chair Matlawski convened the meeting (on behalf of Chair Tom Fillippo), and asked Member Dozor to report on behalf of the Presidential Search Committee.

AGENDA ITEM II - REPORT OF THE SPECIAL COMMITTEE:

Member Dozor, Chair of the Presidential Search Committee, reported on behalf of the committee. Member Dozor reported that this public meeting announcement was advertised in the Daily Local News, as well on the WCU website on the Trustees' webpage, and the announcement of the meeting was posted outside and inside of the Philips Memorial Building.

Member Dozor reported that the committee conducted an intensive and exhaustive search and interview process for two candidates to recommend to the Chancellor in accordance with Board of Governors' policy 1983-13-A, *Process for Recommending Presidential Appointment.*

Member Dozor stated that the committee had two unranked names to recommend to Chancellor Brogan, and he announced those names as follows: Dr. Christopher M. Fiorentino; Dr. Cady Short-Thompson.

Member Dozor made the following motion for consideration and action by the Council of Trustees:
