Dr. Robert Maggio

Dr. Maggio has been on the faculty of West Chester University for over twelve years and during that time has composed over 45 original compositions, many of them commissioned, premiered, and performed by extraordinary musicians and organizations (including the Boston Pops, Philadelphia Orchestra, Atlanta Symphony, Pennsylvania Ballet, and the Chamber Music Society of Lincoln Center.) Of these works, 30 have been published by Theodore Presser Company (with international distribution), 15 have been recorded on the CRI and Albany labels (also internationally distributed), and many have been performed live internationally (in Europe, Australia, Asia, and South America).

He has received composition fellowships from some of the most prestigious peer-reviewed national foundations, including the American Academy of Arts and Letters, the Guggenheim Foundation (1998), and the Pew Fellowship (1999). His music for theater and dance has been performed nationally at the Yale Repertory Theater, Shakespeare Santa Cruz, American Dance Festival, Lincoln Center Out-of-Doors Festival, and the Philadelphia Theatre Company. His first ballet was premiered with the Pennsylvania Ballet in February of 2003 at the Academy of Music in Philadelphia.

Dr. Maggio's work has received high praise by reviewers across the country. These critics are enthusiastic about the quality and originality of his work and often compare it to great works of the previous century. He has consistently brought national and international acclaim to West Chester University through his successful activities as a composer.

Many of these contributions to the field have been completed while Dr. Maggio has been the chair of his department, providing strong leadership and fostering a sense of camaraderie among his peers. He is an excellent teacher, and he inspires his students to follow in his footsteps. He instills a sense of critical awareness in his students through his own enthusiasm and excitement.

Thank you for the opportunity to review the artistic work of composer Robert Maggio. The collection of his compositions form a body of work which is accomplished, personal, professional, and defined by the presence of a voice which is clear and confident.

One of the earliest of these compositions is the *Duo Concertante*, written in 1990. This is a major work in three movements, and the second contrasts with the outer two as a work of expressive lyricism between two statements of driving and forceful rhythm. The characteristics I identify in Maggio's music – lively rhythmic structure, often coupled with repetition of clear segments; lyricism which is always grounded in an individual approach to tonality; and registral contrast that broadens the scope of the music by heightened color – are all present here. This is a wonderful work by any standard.

Other, and later, compositions continue to refine Maggio's vision. These include the music that is written for flute – *Traveling Music*, for flute and guitar; *The Laurel Tree*, for two flutes and piano; *Phoenix*, for two flutes; and, especially, *Fluano Pianute*, for flute and piano. This last piece uses an ingenious structural connection between nonconsecutive movements, linking the latter to the former by repetition of material that seems "interrupted" by an intervening movement. These pieces, and others, present a unified view of a composer who is in complete control of technique and uses it to serve a consistent artistic ambition.

Placing Robert Maggio in the landscape of contemporary composition, I would identify his position as one that joins with the tradition and seeks to find new things to say in music in that context. There is pragmatism in his work, and the strength of the musical idea is always at the forefront of the composition. Maggio is not a composer who has chosen to prop himself up with the supports of a governing philosophical or technical position. His reliance upon his musical instincts to guide the composition of his work results in music which is individual, personal, direct, dramatic, and expressive.

I am pleased to recommend Robert Maggio for the Trustees Achievement Award from West Chester University.

Dr. Marshall J. Becker

Since his appointment to the Department of Anthropology at West Chester University in 1968, Dr. Marshall J. Becker has had a long and productive career as a distinguished professor. While at West Chester University, he taught in three different areas of anthropology and published in physical anthropology and archaeology, as well as in cultural anthropology. His illustrious academic contributions to his discipline, as well as his commitment to excellence in the classroom, are significant.

In 1987, Dr. Becker received the Council of Trustees Achievement Award, recognizing him for his commitment to West Chester University. His contributions include Curator of Archaeology, West Chester University, All-College Museums; Director, West Chester University Archaeological Field School; and service on nine University committees. In addition to his service to West Chester University, Dr. Becker's accomplishments within his profession are numerous.

He has received a number of grants which provided support for his research, including the National Science Foundation, the National Endowment for the Humanities, The American Philosophical Society, the American Council of Learned Societies and the National Geographic Society. This research helped to enhance and enrich the courses that he taught and offered opportunities for students to participate in the field research in seven different countries, including Italy and the Czech Republic.

There is no doubt that during his thirty-six years at West Chester University, Dr. Marshall Becker's commitment and dedication to his field have positively impacted and made noteworthy contributions to the academic lives of his colleagues and students.

Dr. Lynette McGrath

Dr. Lynette McGrath came to West Chester University in 1968 in the Department of English. During her tenure at this institution, Dr. McGrath became known as a scholar, a committed professor and as a departmental leader.

Her history of scholarly work particularly highlights literary contributions of women writers. Her book Subjectivity and Women's Poetry in Early Modern England, crowned thirty years of continuous engagement with her subject matter, and continuous questioning of her own ideas in relation to a fast-changing field. Her work has been published in prestigious outlets such as Women's Studies, Studies in English Literature, Hypatia, and the Encyclopedia of Feminist Literary Theory. Her contributions to her field were many.

In addition to her scholarly work, Dr. McGrath positively impacted the lives of her students over many years. She was an excellent teacher who provoked the best from her students and was accessible and willing to help students achieve the high standards that she set.

Dr. McGrath was known for not settling for the "status quo" within the department, but was always willing to rethink and rework curricula. Her commitment to this pedagogical aspect of her career was rewarded by broadly enthusiastic student response. She was an excellent University citizen through her involvement in Faculty Senate, as Coordinator of the Women's Studies Program, as Assistant Chair, as Coordinator of English Graduate Studies, to name a few.

Over her thirty years at West Chester University, she presented and published close to 60 papers and essays, nationally and locally. She was also involved in research and publications concerning early modern women. Her book, *Subjectivity and Women's Poetry in Early Modern England*, was published by Ashgate, the British press that dominates published studies on early modern women.

Dr. Lynette McGrath was an exceptional teacher and scholar. She earned the respect of her colleagues at West Chester University and in her field of academia, and she made a fundamental difference in the lives of the students she taught and advised.

Dr. George W. Maxim

Dr. George Maxim began his tenure at West Chester University in 1972 and has been an esteemed faculty member for more than thirty years in the Department of Elementary Education.

In 1975, Dr. Maxim received the WCU Excellence in Teaching Award, and he has maintained the same quality of excellence throughout his career at West Chester University. In addition to his excellent teaching of varied undergraduate and graduate level courses, he is a nationally recognized and respected author of four college-level textbooks and numerous journal articles. *Dynamic Social Studies for Elementary Classrooms*, 7th edition (2003), is a basic college methods text and ranks as the first or second most popular text in elementary social-studies education.

During his career at West Chester University, Dr. Maxim served as a member of every committee within the department. On two occasions, he served as Assistant Chairperson. He also served on University-wide committees, many of which he chaired.

Dr. George Maxim has been a valued faculty member of the Department of Elementary Education. He has been an active, productive member of the University whose contributions in the areas of teaching and scholarship are exemplary.

West Chester University FY05 Rate Proposals

A preliminary meeting was held November 11, 2003 to begin discussion of the FY05 Auxiliary Budget Process. Representatives from each area/division were present as well as the Vice-Presidents for Fiscal Affairs and Student Affairs. Three issues that were expected to have a major impact on Auxiliary rates for FY05 were the selection of a new food service contractor, the opening of new, privatized housing on both North and South Campus and the closing of Ramsey Hall at the end of the spring 2004 semester or very early fall 2004. This meeting provided parameters to guide future discussions with the individual directors and development of budgets.

Many of the increases incorporated in the attached budget proposals are beyond the direct control of the individual managers (i.e. contractual salary increases and benefits, utility increases, debt service, etc.). Below are the issues that impact all areas proportionally and cannot be controlled at the department level.

<u>Salaries/Benefits</u>: The current AFSCME contract, effective July 1, 2003, includes a 2.25% step increase for all eligible employees effective the first full pay period of July 2004. These contractual step increases have been built into all AFSCME-related position budgets based on the pay range/step of the current incumbent. In addition, all AFSCME employees at the top of their pay range will receive a one-time lump sum payment equivalent to 2.25% of their annualized base salary. The projected cost for these payments has been budgeted as a separate line item ("General Pay Increase") in individual department budgets based on the current mix of eligible employees in each area.

Both the SCUPA/SUA and OPEIU (nurses) contracts will expire on June 30, 2004. Little information is available at this time although initial salary assumptions received last fall from the System Office do not allow for across the board or step increases in FY05 for these bargaining units. However, in order to provide sufficient budget dollars in the event that across the board or step increases are approved, all SCUPA/SUA lines include normal step increases and OPEIU positions have been increased by 2.25% across the board.

With the exception of managers, all projected salaries are based on the current mix of employees and their rank/step as of July 1st, 2004, the budgeted FTE for the position, and the appropriate pay schedule for that position's bargaining unit. Managers are not covered by a collective bargaining agreement (CBA); pay increases, if any, will be determined by the State System of Higher Education's Board of Governors (BOG) at a later date. Salary assumptions provided by the System office last fall included a 2.5% increase for managers during FY05. In order to provide a pool of funds in the event that the BOG does approve this increase in FY05, all manager lines have been increased by 2.5% for budget purposes.

Initial benefit assumptions have been provided by the System office for use in developing FY05 budgets. All benefit calculations are based on the rate assumptions supplied by the System office as of January 14, 2004. Projected increases for Hospitalization, Annuitant, and Health & Welfare (H&W) are as follows:

AFSCME Annuitant	8.43%

Retirement calculations are based on the retirement selection (SERS vs. TIAA-CREF) for the employee currently assigned. Vacant positions continue to be budgeted based on the TIAA-CREF retirement rate (9.29%). Employer contribution rates for SERS had been declining, but in FY04 the pension board found it necessary to reinstate employer contributions on all employees enrolled in the SERS and PSERS retirement plans. Projected employer retirement contribution rates for FY05 are as follows:

SERS 2.00% (300% change over FY04)

TIAA-CREF 9.29% PSERS 2.115%

Utility Costs:

In response to the closing of Ramsey Hall, Greg Cuprak, Director of Facilities Management, reviewed the University's utility allocation formula and revised the allocations between E&G and Auxiliary facilities based on the actual distribution of square footage between the two funding areas. The only adjustment to the revised allocation was a two percent reduction (from $31\% \rightarrow 29\%$) in the Residence Hall electric rate to factor in the lack of air conditioning in those buildings and decreased usage during the summer months. This allocation formula will need to be reviewed and revised as new E&G buildings come on line and other changes are made in the Auxiliary operation.

All projections are based on current consumption levels and assume that weather and world conditions will not significantly impact fuel supplies/prices.

Auxiliary Fees (including University Health Center)

Overview: Projected increase of \$142 or 5.0% overall increase in Room and Board, Sykes Union and Health Center Fees

Sykes Union: \$55/semester (no increase requested)

Revenue generated from enrollment is projected to be sufficient to meet day-to-day operational needs.

\$15,000 of Sykes general operating budget moved to a new org "Sykes Student Programming" to better track expenditures related to student programs.

Health Center: \$65/semester (increase of \$5/semester or 8.3%)

- > Fee increase necessary to meet salary and benefit increases. Health Center is currently fully-staffed and no significant staffing changes are expected over the next 12-18 months.
- > Revenue projection includes implementation of new \$5/visit co-pay to minimize general fee increase for all students.
- Reserve funds will continue to be used in FY05 to provide additional funding to meet operational needs.
- New full-time graduate assistantship funded from reduction to student wage and overtime budgets.

Food Service: \$937/semester 14-meal plan (increase of \$39/semester – 14-meal plan)

- Overall average increase of 4.7% which reflects actual cost of food plans based on new food service contract.
- Meal plans have been redesigned to offer six options including a new "Block 75 Plan" and "Block 225 Plan".
- New ARAMARK contract includes branded concept dining options such as Chick-Fil-A, Subway and Einstein Bagels.

Residence Halls: \$1,954/semester North Double, \$2,267/semester South Double (increase of 5.3% or \$98/semester North, \$114/semester South)

- > Projected fall/spring room revenue has been adjusted to reflect loss of revenue from closing of Ramsey Hall effective fall 2004.
- > Salaries, benefits and operating expenses have been adjusted to reflect reduced staffing necessitated by the closing of Ramsey Hall.
- > Reductions in student wage and graduate wage, as well as tuition and room waivers, resulting from closing of Ramsey Hall.
- > Transfers for sprinkler installation and LAN upgrade, which were completed in summer 2003, reflect lower projected debt service resulting from refinancing.
- "Bus Service" expenditure eliminated from Residence Hall budget (to be funded from University Parking and Garage revenue).

Miscellaneous Fees

Late Payment Fee: \$50 (new fee FY05)

- New fixed amount fee for implementation in Fall 2004 to be assessed on all semester bill payments received after the due date.
- > Currently 11 of 14 System schools assess a penalty for late payments.
- > Will assist academic departments as an enrollment management tool to determine class size and availability of seats during drop/add process.
