

# RATIONALE FOR HONORARY DEGREE NOMINATION RICHARD D. MERION

As an alumnus of West Chester University, General Richard D. Merion has been and continues to be one of the University's most successful and community-minded graduates. In addition to an outstanding military career, General Merion has provided leadership for a number of military service organizations, volunteered actively with community non-profits, and dedicated countless hours of service to his alma mater. And thanks to his business acumen, Mr. Merion has provided substantial support to the University to advance its mission.

After completing his WCU undergraduate degree in 1959 (Bachelor of Science Degree in Science Education), Mr. Merion began a 32 year career in the active military and reserves retiring as a brigadier general in 1987. He is one of only four WCU alumni to have achieved this rank. While in service to his country, General Merion earned a Master's degree in Public Health from the University of Michigan (1967) and returned to West Chester to receive a Master's Degree in Education (1969). He also earned a Master of Science Degree in Strategic Studies from the US Army War College and certificates from the Command and General Staff College and Industrial College of the Armed Forces.

General Merion's military career included leadership roles in the infantry where he commanded rifle and weapons platoons (1963-69). He was also Commander of the 304<sup>th</sup> Cavalry Brigade (1980-83) and a member of the General Staff of the 353<sup>rd</sup> Cavalry Command (1983-87). In recognition of his outstanding service, General Merion has received numerous awards, medals, citations, and commendations.

During and after his military career, Mr. Merion has volunteered with dozens of organizations setting an example for all WCU students and alumni. For instance, he served as President of the USO of Pennsylvania & New Jersey (1994-98) and was a member of that group's Board of Directors for two decades (1985-2005). He continues to volunteer with the USO. In addition, General Merion was the National Commander of the Centennial Legion of Historic Military Commands (1999-00), President of the Sons of the American Revolution's Philadelphia Chapter (2005-06), and Pennsylvania State Chair of the US Department of Defense Committee on Employers Support of the Guard and Reserve (1986-2002). He also continues to serve as Vice President for several Greater Philadelphia service groups including the Chapel of the Four Chaplains, Association of the US Army, British Officers Club, and the Military Officers Association of America. He is also a member Congressman Joe Pitts' Military Academy Selection Committee.

Along with his stellar efforts to support men and women in the armed forces, General Merion has contributed significantly to other non-profits. Since 1999, he has served as a member of the West Chester Area Senior Center Board of Directors and is currently a volunteer and member of the Advisory Committee. He is also an active participant in the Chester County Chamber of Business and Industry and is President of the Conestoga Shrine Club. And after completing his active military service, Mr. Merion demonstrated his entrepreneurial talents developing and serving as President of several companies including the Barnegat Bay Trading Company (NJ) and Development Services, Inc (PA). He also serves as President of the Franklin Water Company and Chester County Utilities (both located in Pennsylvania).

With this remarkable record of career and community service, General Merion has never forgotten his alma mater. He has served on the West Chester University Alumni Board of Directors since 1980 and was President of that organization in 1991 and 1995. In recognition of his service to the Alumni Association he was named an emeriti trustee and received the Distinguished Alumni Award. Also, General Merion has chaired the business section of the WCU Annual Fund Campaign and has been a long-time member of the Presidential Scholarship Gala Committee. He also works with the WCU Army ROTC unit and was named Honorary Commander by the members. Philanthropically, General Merion has been a regular and avid supporter of the University. In particular, he has established an endowed scholarship for science majors, given significantly to the annual scholarship fund, and most recently, contributed a leadership gift which resulted in the University naming one of the campus science buildings in his honor.

Without question, General Richard D. Merion has rendered outstanding service in the public interest through actions which have benefited thousands of people, served the national interest, and advanced the mission of West Chester University. His contributions to the public good serve as a model for all WCU student and alumni.

President Madeleine Wing Adler has requested that the Honorary Degree Committee solicit your participation in identifying nominees for this distinguished award. The award recognizes the achievements of persons who have made significant contributions to the progress of the University or its academic or professional disciplines.

**Eligibility:** Honorary degree recipients to be honored by the University's academic community are selected on the basis of their distinguished service, creativity, scholarship, or other individual accomplishment in the service to humanity. These men and women are often--but not exclusively--selected from prominent alumni, business persons, philanthropists, civic leaders, national leaders in public affairs, outstanding educators, industrialists, artists, public servants and prominent scholars in the arts, sciences, and the humanities. Therefore, honorary degree recipients can be academicians of national or international reputation; persons who have made estimable contributions to American higher education in a field related to the University's interests; persons who have made meaningful contributions toward the development of a major University program; persons with long and distinguished service to the University; and persons whose contributions embody the University's purpose, values, and mission.

In accordance with the Board of Governor's policy, honorary degree designations are limited to degrees not given in courses as earned degrees by any post-secondary institution authorized by the Commonwealth to grant such degrees. Commonly awarded honorary degrees are:

1. Doctor of Laws (LL.D.; <u>legum doctor</u>) is the most popular honorary doctorate. Despite a variety of recipients (clergy, bankers, politicians, scholars), it is regarded as the most appropriate award for a person distinguished in general service to the state, to learning, and to humanity.

2. Doctor of Letters (Litt.D.; <u>litterarum doctor</u>) is considered an appropriate reward for scholarly work of a somewhat restricted nature. It is usually conferred upon scholars in particular disciplines.

3. Doctor of Science (Sc.D.; <u>scientia doctor</u>), a popular award for persons who have made reputable contributions and performed service in the sciences.

4. Doctor of Humane Letters (L.H.D.; <u>litterarum humaniorum doctor</u>) is the honorary doctorate usually given to persons who have distinguished themselves in the humanities.

5. Doctor of Public Service (D.P.S.; <u>doctor beneficiorum publicorum</u>) honors those who have rendered outstanding service in the public interest through actions or thought that have resulted in tangible contributions to the public good.

6. Doctor of Pedagogy (Ped.D.; <u>doctor institutionis</u>) is awarded to those whose life achievements exemplify the science, art or profession of teaching and who have demonstrated originality in thought in these areas.

Other honorary degree titles include, but are not limited to: Doctor of Music (D.Mus.), Doctor of Education (Ed.D), Doctor of Fine Arts (D.F.A.), Doctor of Civil Law (D.C.L.) and Doctor of Public Administration (D.P.A.).

**Restrictions:** Honorary degrees cannot be awarded to active members of the Board of Governors, Council of Trustees, Administrators or faculty. They cannot be awarded to former members of the Board of Governors, Council of Trustees or University employees until at least one year after their association with the University has lapsed.

# MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (hereinafter "MOU") is made by and between the West Chester University Alumni Association (hereinafter "WCUAA") and West Chester University (hereinafter "WCU") this  $\underline{27}$  day of  $\underline{Jyz}$ , 199.7

# **Background**

WHEREAS, the WCUAA and WCU have a long tradition of supporting each other for the common good of WCU and its Alumni; and

WHEREAS, historically the WCUAA had conducted fundraising activities and campaigns to solicit donations from Alumni; and

WHEREAS, WCU has likewise conducted fundraising activities to solicit funds from Alumni to support WCU; and

WHEREAS, the WCUAA and WCU desire to coordinate the various fundraising activities that both the WCUAA and WCU conduct; and

WHEREAS, the WCUAA desires to limit its fundraising activities and promote various WCU activities in exchange for an annual operating budget and receipt of specified services from WCU to the WCUAA; and

WHEREAS, the WCUAA owns the Veteran's Memorial Alumni House (hereinafter "VMAH"); and

WHEREAS, the WCUAA is responsible for the maintenance and repair of the VMAH; and

• WHEREAS, the WCUAA maintains separate from WCU various financial accounts and investments for purposes of endowments, scholarship, the VMAH, and other financial reasons; and

WHEREAS, the WCUAA and WCU desire to memorialize the terms and conditions of their relationship in order to facilitate coordination and cooperation between them and to pursue their common goals, and 3. Serve as the Editor for the *Ramparts* section of the *West Chester* University Magazine. In this capacity, assist in the gathering, verification, and drafting of news and information for the WCUAA.

4. Develop and maintain a positive reciprocal relationship with the WCUAA and its Board of Directors.

5. Provide all day to day services for the operation of the WCUAA.

6. Assist the WCUAA in developing organizational goals.

7. Attend the WCUAA Board of Directors, Executive Council, Finance Committee, and House and Grounds Committee meetings to the best extent possible, and in the DASE's absence, direct the attendance of an alternate from the Office of Alumni and Special Events.

8. Provide written monthly and annual budget updates identifying all revenues and expenditures to the Executive Council, Finance Committee, Board of Directors and the WCU Vice-President of Advancement.

9. Represent the interests of the WCUAA at appropriate WCU

Committee Meetings.

10. Prepare and present an annual budget for the WCUAA and the Office of Alumni and Special Events and supervise the implementation of the budget.

11. Assist the WCUAA in the publishing of a handbook for each of the WCUAA Committees.

# III. WCUAA Finances and Budget.

A. <u>Unified Account</u>. The previous accounts of 7101 and 7103 will now be combined into one unified account which will be maintained for the financial operations of the Office of Alumni and Special Events and for the programming expenditures of the WCUAA. WCU will provide an approximate minimum annual funding of \$58,000 to \$60,000 for this account and its budget.

B. <u>WCUAA Veteran's Memorial Alumni House Fee</u>. WCU will pay the WCUAA by July 1 of each year the amount of \$5,000 as a fee for the use of the VMAH by WCU affiliated organizations. The \$5,000 payment will be deposited into a separate of two officers of the Executive Council and the approval of the WCU Vice-President for Advancement. Any changes to the programming portion of the budget other than a line item revision and any changes to the total overall amount of the budget will require the approval of the WCUAA and WCU Vice-President for Advancement.

# IV. WCUAA Fundraising.

1. The WCUAA and its Chapters will not conduct fundraising solicitations of the general alumni body. However, after consultation with WCU, the WCUAA can engage in sponsorship of the sale of products for the purpose of generating extra revenue.

2. In the event that financial donations are sent directly to WCU or to the WCUAA made payable to the WCUAA without further directives or notations indicated, the donor will be contacted and asked for further instructions as to whether the donation is intended for WCU or to the WCUAA. Thereafter, the donation will be transmitted accordingly.

3. In the event that donations are sent directly to WCU or to the WCUAA with directives or notations that the payment is made for the benefit of the VMAH, then these payments will be deposited as directed by the WCUAA for the benefit of the VMAH.

4. Gifts benefitting the VMAH will not be considered to be part of the

WCU Annual Giving.

V. <u>West Chester University Magazine</u>. WCU will provide the WCUAA with up to 37 pages per year of space within the West Chester University Magazine for the Ramparts section devoted to Alumni events and news. A Ramparts section may be included in all four quarterly issues of the West Chester University Magazine. The DASE retains editorial control for the contents of Ramparts and stylistic and format decisions are the responsibility of the Magazine Editor.

# VI. Review of Memorandum of Understanding.

A. The initial term of this MOU will be from July 1, 1997 to the ending date of June 30, 199%. The ending date will establish the annual "anniversary date" which is defined as that same month and day during succeeding years.

B. The MOU will automatically renew and continue in effect for additional one (1) year periods commencing from the ending date to the first anniversary dates, and then from anniversary dates to anniversary dates.

Articles of Amendment

In compliance with the requirements of the Act of May 5, 1933, P.L. 289, Article I, Section 14, as added by the Act of June 19, 1969, P.L. \_\_\_\_\_, No. 31, Section 1, the Applicant desiring to amend its Articles of Incorporation hereby certifies under its corporate seal that:

1. The name of the corporation is: ALUMNI ASSOCIATION OF THE STATE TEACHERS COLLEGE AT WEST CHESTER.

2. The location and post office address of its initial registered office in this Commonwealth is: Alumni Office, Philips Memorial Building, High and College Avenues, West Chester, Chester County, Pennsylvania.

3. The Act of Assembly under which the corporation was formed was: The Nonprofit Corporation Law of Pennsylvania entitled "An Act to provide for the incorporation and regulation of certain corporations" approved the 29th day of April, A.D. 1874 and its supplements. The said Articles were filed in the Office of the Recorder of Deeds in and for Chester County, in Corporation Book No. 4, page 263, on June 18, 1898. Articles of Amendment thereto were duly filed in the Office of the Recorder of Deeds in and for Chester County, in Corporation Book No. 8, page 500, on June 24, 1929.

4. Written consent to the amendment has been given by all members entitled to vote thereon. The said Resolution approved by the members by written consent contained the language of the proposed amendment as set forth in paragraph 5 hereof and provided that the Articles of Amendment should be amended in accordance therewith.

5. The proposed amendment or addition to the existing Articles is as follows:

(a) Paragraph 1 of the said Articles of Incorporation, as amended, shall be further amended by striking paragraph 1 therefrom and setting forth in lieu and substitution thereof, the following:

"The name of the corporation shall be Alumni Association of West Chester State College".

(b) The Articles of Incorporation shall be further amended by adding thereto a new paragraph 8 providing as follows:



# ARTICLE I

# Name

The name of this association shall be the West Chester University Alumni Association, hereinafter referred to as the "Association." The Association was incorporated in 1898 under the laws of the Commonwealth of Pennsylvania,

# Purpose

# ARTICLE II

The purpose of the Association shall be to promote the interests of West Chester University in all areas of academic, cultural, and social needs; to strengthen the Association through a strong network of graduates; and to increase alumni

# ARTICLE III

# Members

Section 1. Any person graduating from West Chester Normal School, West Chester State Normal School, West Chester State Teachers College, West Chester State College, or West Chester University becomes and remains a member of the Association. All nongraduates who have attended West Chester University or its predecessors for at least two semesters and whose classes have graduated may become members of the Association upon request.

Section 2. All members of the Council of Trustees, the Faculty, and the

Administration of West Chester University shall be considered and taken to be honorary members of the Association. Any person may be elected an honorary member of the Association by the Board of Directors (hereinafter referred to as the "Board") at any regular meeting of the Board by a majority vote of said Board. Honorary members shall neither vote nor hold office in the Association.

# Officers

# ARTICLE IV

Section 1. The officers of the Association, who comprise the Executive Council, shall be as follows: President, Vice President, Secretary, Treasurer, and

Section 2. The duties of the officers of the Association shall be as follows:

### ARTICLE VIII

### Meetings

Section 1. The Annual Meeting of the Association shall be held in May on a date and at a location to be determined by the Board. Twenty-five members for the Association shall constitute a quorum.

Section 2. The Board shall hold six regular meetings. The Executive Council, no later than August 1, shall determine the meeting calendar for the year and shall notify all Board members of the dates. Special meetings of the Board may be called by the President of the Association and must be held upon a call signed by AT LEAST four Board members. Ten members of the Board constitute a quorum.

Section 3. Within the operating year, July 1 through June 30, Directors shall not be absent for more than two of the six scheduled Board meetings. Any Director absent from more than two of these meetings shall be deemed to have resigned immediately, and that seat shall be filled in accordance with Article IX, Section 4.


